## Restorative Youth Justice (Circle Keeper)

We are seeking a highly motivated individual that is focused on helping others to heal and help them to work on personal growth as well as working towards a healthier positive lifestyle choice. Restorative Justice involves circle process to help with mediation, regarding criminal matters, civil matters, conflict resolution, lateral violence, bullying, cyber bullying. Although the primary focus of the position is youth, the role is an integral part of the Restorative Justice Team, co-facilitating Circle process, which also includes working with the Healing to Wellness Court Team.

## **Job Description:**

- Assess and evaluate the suitability of potential clients to determine if Restorative Justice processes would be appropriate to assist them in their current situation.
- To work on establishing a relationship with both the harmer(accused/offender) and the Harmed(victim), and the community, with the premise of meeting in circle process to work towards collaboration and resolution of the conflict at hand.
- To maintain the safety and integrity of all participants within circle process, ensuring that everyone is safe, and engaged, and to prevent further harm to the relationship, while in circle.
- To understand the importance of confidentiality, and the impacts it has on relationships within the community.
- Co-facilitate Circle Processes, with Community Justice Facilitator (Circle Keeper)
- Ability to make appropriate recommendations in circle process, utilizing local resources and a wholistic healing approach.
- To maintain accurate and up to date records of work undertaken with young offenders and their families.
- Develop and strengthen professional relationships with referring agencies.
- Collaborate with other professionals regarding resources for young people.
- Attend and contribute to professional meetings, where appropriate
- Provide opportunities for offenders, victims, and communities affected by a crime to communicate (directly or indirectly) about the cause, circumstances, and impact of that crime, and to address their relative needs.
- Encourage meaningful engagement and accountability and provides an opportunity for healing, reparation, and reintegration.
- To be an effective and integral part of the Restorative Justice team, to co-facilitate Circle process with Community Justice facilitator, as well as work with the Healing to Wellness Team, and their clients.
- To carry out other duties and jobs, as required by the Executive Director of BGC Saddle Lake, to whom the Saddle Lake Restorative Justice Team reports to.
